
SME posted strong profits in Q1 2022 despite several market factors that turned the overall industry margins back to historical norms. Corn price continues to rise, making several new record highs in the face of continued inflation and the Russian invasion of Ukraine. Ethanol prices dropped significantly in early January, and have since recovered, keeping the gross ethanol crush positive when we include all co-product sales. The financial results are found on page 2 of this newsletter.

On April 12, President Biden visited an ethanol plant in Menlo, lowa to annouce that the EPA will issue a nationwide waiver to allow sales of E15 through the summer. During his prepared remarks, he confirmed what we already know; ethanol lowers price at the pump, reduces emissions, and supports American manufacturing. While we don't anticipate this move will drastically change the fuel ethanol business, we welcome the Presidential de-bunking of ethanol myths propagated by the well funded oil lobby.

We continue to make excellent progress launching the GNS business. We have steadily increased shipments and will exceed 1 million gallons per month of sales in the second quarter of 2022! Having more options for our products helps all of our marketing efforts and is contributing to our positive results.

In the last newsletter we asked you to consider your Show Me Ethanol shares as part of your estate planning, adding a TOD or other instructions in the event that your shares need to move to a different owner. Your response has been outstanding, thank you!

Financial Results for First Quarter Ended March 31, 2022

Total Sales were made up of \$34.5 million of Ethanol, \$9.2 million of Distiller Grains, \$3.5 million of Corn Oil and \$3.3 million of GNS.

Total Expenses include Corn costs in the amount of \$37.6 million. Net Income for the 1st quarter of 2021 was \$3.7 million.
